

## INSURANCE INFORMATION in case of short-term and insured long-term leases

All equipment leased for short-term and upon separate agreement of the Parties also the equipment leased for long-term are covered for the lease term by JUNGHEINRICH Hungária Kft's equipment rental insurance.

Insured: JUNGHEINRICH Hungária Kft.

Co-Insured: Companies with Hungarian seat and registered in Hungary

using the services of JUNGHEINRICH Hungária Kft. according to contract – without separate notification – the current lessee of the forklifts owned by the Insured (hereinafter referred to as

Client)

Own contribution: 10%, but at least HUF 100,000 per damage case

Type of Insurance: Insurance of Machinery Breakage

The Client declares that it has permanent Internet access. The Client expressly declares that it has become familiar with the documents available under the links indicated above prior to the conclusion of the One-Time Contract and following due diligence and close examination accepts those as part of the One-Time Contract and concludes the One-TimeContract against this background. The Client also states that regarding the documents it chooses expressly this form of disclosure of information and does not require the delivery and/or sending the documents in any other way.

The insurance covers, for example, the following events, in connection with which the insurer compensates for damage to the insured property:

- "all risks" cover: external mechanical effects (covers all external accidental damage

   not excluded in the terms and conditions -), such as: overpressure, vibration, resonance, fire and elemental damage (such as. elementary damage, damage to mains water, fire extinguisher puncture, bursting of process piping, fire caused by electricity, damage caused by smoke and heat emission, secondary effects of lightning, collision with a vehicle), rescue costs, moving and protection costs.
- machinery breakdown insurance: covers e.g. damage to machinery and equipment during work, internal breakage during operation, incorrect installation, unintentional overloading, etc.)
- burglary and robbery, partial theft, vandalism insurance: if the conditions of protection are fulfilled on the spot.

The insurance does not cover/ the insurer is exempted from the obligation to provide services in particular

 in the event of intentional or grossly negligent and/or repeated breach of professional rules and

• if the insured is in breach of either a duty of prevention or a duty to mitigate damage, whether grossly negligent or intentional.

The Client shall be obliged to inform JUNGHEINRICH Hungária Kft. and the assigned insurance broker (Eurorisk Kft.) about any damage (harmful event) within 2 days (48 hours) upon detection thereof, in writing (e-mail) in the form of a protocol.

JUNGHEINRICH Hungária Kft. will invoice the Client the total cost of the repair and the Client shall be obliged to pay it without any deduction. The Insurer will pay the compensation directly to JUNGHEINRICH Hungária Kft - as contracted Insured - - and JUNGHEINRICH Hungária Kft. shall arrange for the payment of the amount to the Client immediately after the settlement of the invoice mentioned above.

## Right of JUNGHEINRICH Hungária Kft. to terminate:

In particular that also the Insurer is entitled to modify the insurance fee payable by JUNGHEINRICH Hungária Kft., JUNGHEINRICH Hungária Kft. reserves the right to revise the insurance cost structure element of the rental fee paid by the Client at the end of each calendar year. Insofar as no agreement with Client is reached thereto until December 15 of the calendar year, JUNGHEINRICH Hungária Kft. is entitled to terminate its insurance services without any disadvantageous legal consequences by the end of the calendar year. This termination does not affect the other services (lease, full-services etc.) of JUNGHEINRICH Hungária Kft.

In case of the above termination of the insurance services, the Client is obliged to take out a comprehensive insurance for machinery breakage without delay and to keep such insurance continuously alive during the validity of the One-Time Contract. Beneficiary of the insurance shall be JUNGHEINRICH Hungária Kft. The Client shall present to JUNGHEINRICH Hungária Kft. the insurance certificate complying with the above-mentioned requirements at the same time as taking out the insurance and shall provide credible proof of the certificate of cover and/or the payment of the premium at the frequency of the premium payment schedule, or upon request of JUNGHEINRICH Hungária Kft.
