- Our workplaces are safe from a health and ergonomics point of view, and are regularly risk assessed in line with modern technology and occupational healthcare standards.

 We focus on preventing injuries, accidents and work-related illnesses. All accidents are recorded and analysed, and appropriate measures are implemented to prevent such accidents in the future. We aim to reduce the number of work-related accidents and the resulting absences from work to an absolute minimum.
